CORRIGENDA/ADDENDA NO. 10 TO BIDDING DOCUMENTS

Bidding Documents: Main Civil Works of 600 MW Kholongchhu Hydroelectric Project

Pursuant to Clause 11 [Amendment to Bid Documents], Volume 1 - Instruction to Bidders (ITB) of Bidding Documents, this Corrigenda/Addenda No. 10 to Bidding Documents is hereby issued as follows:

A. Volume – 1: Instructions to Bidders (ITB)

1. **Sub-Clause 8 of NIT at Page 7, Notes for Technical Criteria Clause 5 (ITB) at Page 13, Sub-Clause 6.1 [Nature of Bidders] of ITB at Page 14 & Notes for KC-1 of IFB at Page 48**

The words appearing as:

“off-load at least 20% of the value of contract to Bhutanese Contractors/Entities”

stand deleted and substituted by:

“off-load at least 20% of the value of work to the Bhutanese Contractors/Entities at the awarded rates of contractor”

B. Volume – 2: General Conditions of Contract (GCC), Particular Conditions of Contract (PCC) and Appendix to Tender

1. **3rd sentence of 3rd paragraph of Sub-Clause 14.2 [Advance Payment] of PCC at Page 29 & 4th paragraph of Form - 9: Proforma for Hypothecation Deed for new Construction Equipment at Page 122**

The words appearing as “90% (ninety percent)” stand deleted and substituted by “100% (hundred percent)”

2. **Sub-Clause 14.5.1 [Materials] of PCC at Page 30**

Delete the second sentence of the first paragraph:

“Other considerations being equal, the contractor shall give preference to Bhutanese firms / nationals for allocation of work and procurement of materials to the extent possible”

and substitute it by:

“Other considerations being equal, unless otherwise specifically stated, the contractor shall give preference to Bhutanese firms / nationals for allocation of work and procurement of materials to the extent possible”

C. Volume – 3: Bill of Quantities

1. Bill of Quantities

The “Volume 3 Bill of Quantities October 2018” booklet issued earlier stand replaced with “Volume 3 Bill of Quantities July 2019” booklet issued vide this Corrigenda No. 10.

All the rewordings / corrections in the Bill of Quantities issued earlier vide Corrigenda No. 2 and Corrigenda No. 3 stand corrected / nullified with the “Volume 3 Bill of Quantities July 2019” booklet issued vide this Corrigenda No. 10.

The hard copy of Revised BoQ “Volume 3 Bill of Quantities July 2019” essentially required by the bidder for filling up the quotes shall be available for collection at the Office of Procurement & Contracts Division, Kholongchhu Hydro Energy Ltd., Trashiyangtse, Bhutan. It will also be available for collection by the authorized representative(s) of prospective bidders during the pre-bid meeting at New Delhi on July 25, 2019.

D. Volume – 4: Technical Specifications

1. Sub-Clause 6.5.iii [Underground Excavation] of TS at Page 64

The word appearing as ‘150 mm’ for B-Line is deleted and replaced with ‘100 mm’.

2. Sub-Clause 6.5.iv [Underground Excavation] of TS at Page 64

The sentence appearing as “The C-Line is a line which is beyond and parallel to the B-Line (Pay Line). The distance between B-Line and C-Line shall be 400 mm” stand deleted.

3. Sub-Clause 6.6.ii & iii of TS at Page 64 / 65 & Sub-Clause 6.20.4.iii of TS at Page 76 [Underground Excavation]

The word appearing as ‘C-Line’ is deleted and replaced with ‘B-Line’.

1. Tender Drawings

The “Volume 5 Tender Drawings October 2018” booklet issued earlier stand replaced with “Volume 5 Tender Drawings July 2019” booklet issued vide this Corrigenda No. 10.
