CORRIGENDA/ADDENDA No. 1

Name of the Tender: Supply of Geophysical Equipment

In accordance with the provisions under Clauses 11.1, 11.2, 11.5, 13.1, and 13.4 of 'Instruction for Bidders' under Section II of the Bidding Document, the following Corrigenda/Addenda is hereby issued for modification of the Bidding Document:

1) SECTION – I: INSTRUCTION TO BIDDER

a. Clause ITB 23: Bid Security

Add the following sentences at the end of the clause 23.2:

“Bid Security BG in the form of Swift message shall also be accepted. In doing so, Bidders shall ensure that the Bid Security amount does not fall short due to any related banking charges. Further, Bid Security routed through Correspondent Banks of the Banks in Bhutan shall also be accepted”.

The details of the Bank Account of the Correspondent banks are attached herewith under *Annexure-I*.

2) SECTION – III: TECHNICAL SPECIFICATION

a. Seismic Refraction Tomography

Add the following sentence at the end of point no. 10:

“Any seismic source which can work for the spread length specified in the Technical Specification shall be acceptable”.

3) FORM 13: PRICE SCHEDULE

Add the following sentence at the end of Price Schedule E: Related Services / Training

“The training must be carried out at site and not online since hands on training is required for the equipment operators.

For deputation of the trainers, other than the quarantine charges as mentioned under GCC. 15.2 of the Special Conditions of Contract, no other claims or charges (such as idle charges) shall be borne by DGPC.
